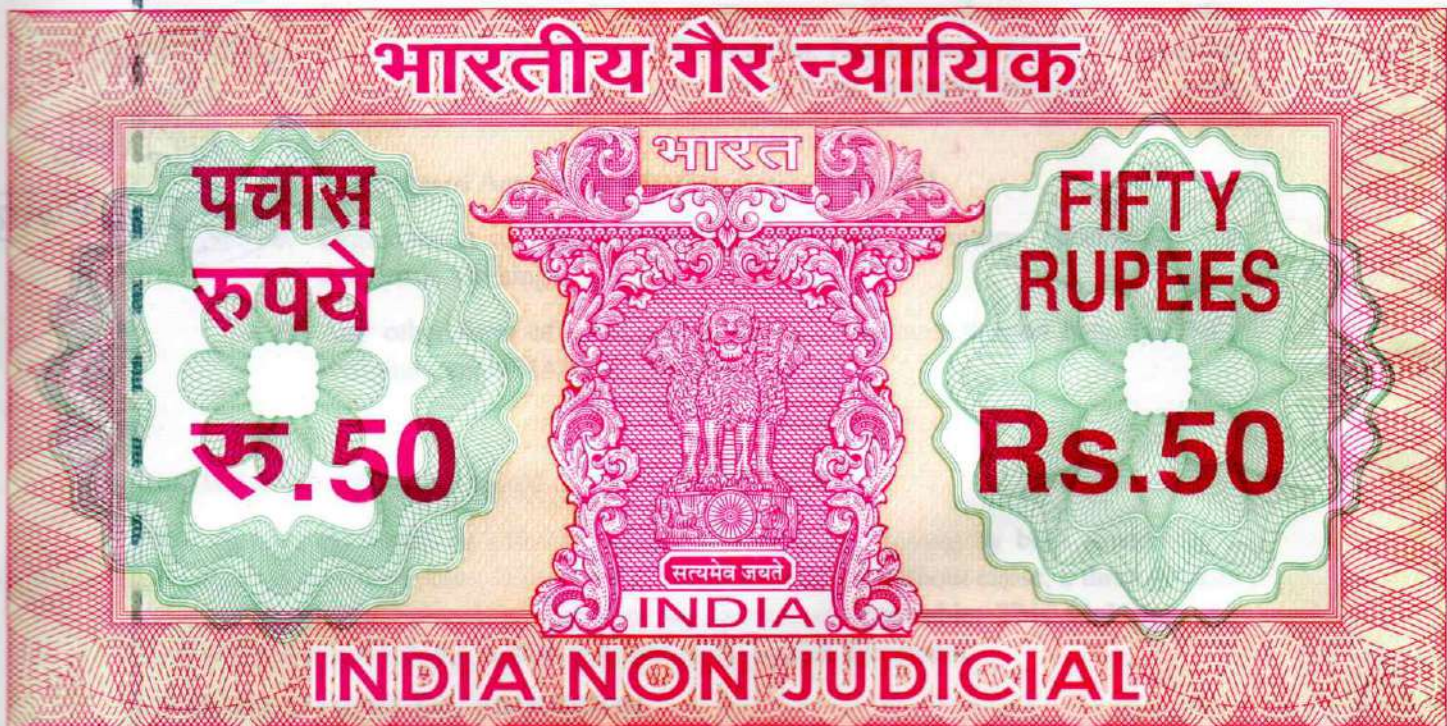

The Memorandum of Understanding (MoU) is drawn up and agreed upon to establish Academic and Research collaboration between The Jawaharlal Nehru College, Pasighat-791103, Arunachal Pradesh, India hereafter referred to as JNC and North Eastern Institute of Ayurveda & Folk Medicine Research, Pasighat, Arunachal Pradesh— India hereafter referred to as NEIAFMR to disseminate knowledge to the mutual benefits of both the Institutes.

The two parties recognize resource development and institutional capacity building as the basis of a mutually beneficial cooperative programme, hereinafter referred to as the Programme. This memorandum is established in the year 2023 for five years.

### ARTICLE I: OBJECTIVES OF THE PROGRAMME

The objective of the programme is to provide opportunities for collaborative research work.

### ARTICLE II: SCOPE OF THE PROGRAMME

The Programme initially for five years and plans to provide collaborative cooperation through:

- Collaborative research programs in specific fields of interest** – JNC, Pasighat and NEIAFMR, Pasighat will jointly identify specific fields to conduct collaborative research programmes of mutual interest and benefits.
- Student exchange programme** - The exchange programme for JNC, Pasighat, and NEIAFMR, Pasighat, students will be explored and conducted accordingly which will be mutually beneficial for both parties. Launching of Joint Research Activities, the Exchange of Faculty Members/ Research Personnel will be explored and conducted.

- c. **Faculty/Scientist exchange programme** - The exchange programme for JNC, Pasighat, and NEIAFMR, Pasighat, Faculty/Scientist will be explored and conducted accordingly which will be mutually beneficial for both parties.
  - d. Exchange of Academic and other Publications, and
  - e. Organization of Joint Conferences, Seminars, Trainings, Workshops and Academic Meetings.
  - f. Any other form of co-operation that may be agreed upon between JNC, Pasighat, and NEIAFMR, Pasighat.

### ARTICLE III: DURATION OF THE PROGRAMME

This Memorandum will be effective from the date of its signing by both parties for a period of the next five years. If this MoU is to be terminated without cause, a three months prior notice should be sent by either of the parties as applicable; This MoU may be renewed by mutual consent of both institutions by written agreement.

### ARTICLE IV: SPECIAL PROVISION

- Both parties shall exchange useful information on each other's educational, research training programmes and other activities related to academics.
  - Both parties hereto shall do their utmost to ensure smooth and efficient implementation of the Programme.
  - Both parties shall exert their best effort to be available for mutual consultation and shall be prepared to provide necessary information whenever reasonably requested.
  - Any amendment to this MoU shall be made in writing and mutually agreed upon.
  - All disputes arising in connection with the interpretation or application of this MoU shall be settled amicably through mutual negotiation.
  - The two parties will maintain efficient communication to ensure the effective implementation of the Programme.

### Terms of the memorandum:

Both parties agree to carry out the above-mentioned activities by the law and regulations of the respective University and Institution after full consultation and approval. The parties acknowledge that this MoU does not in any way give rise to any right or permission to use or to be associated with each party's intellectual property. Under collaborative research, any patentable research conducted by faculty or student in coordination with other parties, sharing of the intellectual property rights will be as per the IP Policy.

### Confidentiality:

Each party shall undertake to observe the secrecy of confidential information received from or supplied to the other party during the research activities conducted within the period of implementation of this MoU or agreement made pursuant to this MoU.

For the purpose of MoU, "Confidential information" means any information whether prior to or hereinafter disclosed by a party (the receiving party) of this MoU involving technical,



business, marketing, policy, know-how, planning project management and other information, data and/ or solution in any form.

All information known or received by a party to the other party to this MoU will be kept confidential and will not be disclosed to any third person.

**Settlement of Disputes:**

- a) Any difference or dispute between the parties concerning the interpretation and/ or application of any of the provisions of this MoU shall first be settled amicably through mutual consultation and/or negotiation between the parties.
- b) Any issue which cannot be resolved within general terms of the MoU will be sought to be resolved through Arbitration Proceedings involving the parties concerned.
- c) In case any issue(s) demanding resolution beyond mutual settlement will be subject to local jurisdiction of the judicial proceeding within the State of Arunachal Pradesh (District East Siang), India.

**Revision, Variation and Amendment:**

Either party may request in writing a revision, variation or amendment of this MoU. Any such revision, or variation of the amendment agreed to by the parties shall be in writing and shall form part of this MoU. Such revision, variation or amendment shall come into force on such date as may be determined by the parties. A minimum period of six months' notice will be required from either party wishing to terminate or amend this agreement. In the event of termination, the relevant parties will honour all commitments to students participating in the Programme.

This MoU is prepared in two identical copies; each party will hold one original copy duly signed by the respective Vice Chancellor/ Head of the Institute. This agreement shall take effect from the date of signing by both parties.


